RULB FOR THE GUIDANCH OF CANDIDATES L. The examination will commerce on and will continue from day to day as per examination programme already potified. 2. Candidates suffering from any disease which would sender their presence in the examination hall understrable in the interests of other can lidates will not be allowed to entre the examination ball. The doors of the examination hall will be opened half an hour before the examination starts on the first day and 13 minutes before on other days. A seat with the same number as on his admission card assigned to each candidate will be provided and he should be in his seat 5 minutes before the examination begins. Candidates arraving after the examination has started will not be admitted except with special permission of the Superiulendent. This permission will in no case be given to a candidate who is more than balf an hour late. Candidate should bring their own Pens and mathematical instruments. No book or papers printed os manuscript other than their admission cards should be taken into the examination centre. Candidates should not have in their possession while in the hall any books or paper printed or manuscript even if they are unconnected with subject of the examination except their admission card, connected question paper, answer books, graph sheets etc. as are provided by the centre for the examination being held at the time, Lagarithm-tables shall be provided by the centre for mathematical calculations. Calculators or computers shall not be allowed. 1. Candidate should-not misbehave with any Officer connected with the confact of the examination in the examination hall or in the premises of the examination centre. Candidate are not allowed to leave the hall before one hour after an examination starts. They should not leave their scats until they have submitted their answer books to an invigilator. Answer books should not be left behind on the desk. No Candidate will be allowed to se-enter the examinations hall after once quitting it. In case of ungent need however a candidate may be permitted by the Senior Invigilator to leave the hall temporarily under special supervision. Candidates are not permitted to talk to each other in the examination hall. No one should receive help from or assist another in any manner. A candidate should not write on the out side of his answer book the Roll number and such of ter distinguishing marks as are given to him on the admission card and should on no account write any where in his answer book, his own name of Roll No. of the name of college or anything else that is not strictly connected with the answer to the question given. Formishing felse Roll Number on the cover page is a serious offence and no answer book without the candidates Roll Number clearly written on the outside will be examined. The results of the candidate who shall be found to have written his name/roll no./college/ any identifying mark will be cancelled. Candidates while in the examination hall neither write anything on the question papers or blotting papers nor should they take out of the ball any paper other than the question papers. In case a candidate intends to change the ink or pen he/she should take the permission of the Invigilator and bis signature on the enswer book. Candidates should note that their answer shall be valued from the beginning of the answer book serially without omitting any answer in the requisits number of optional question are covered. Answer to compulsory questions will be examined in any case. Answer to optional questions of any beyond the requisite number shall not be valued. 11. A candidate wishing to say anything should standup at his Seat and remain standing until the Invigilators come to him. He should on no account, leave his seat or make any noise to call the invigilators attention to bim. Persons unconnected with the conduct of the examination, whether relations of candidates or otherwise shall not be allowed to enter the examination hall. Infriengement of any of the above rules will rander the candidates liable to expulsion from the examination ball or any such further penalties that the authorities may deem fit to impose.
